COVID-19 in Ontario

- Continuation of the renewed provincial state of emergency
 - Renewed previous orders
 - Continued public health protection advice with warmer weather and upcoming holiday weekend important to keep measures in mind
 - Continue physical (previously called social) distancing and self-isolation if unwell without waiting for testing
 - No gatherings of more than five people, with exceptions for households of more than five people and funerals of ten
 - Ministry of Health (MoH) recommends anyone over 70 years of age selfisolate due to increased severity of disease and complications seen in older people

FNIHB Activities

- New ministry self-assessment tool that can be done by anyone wondering if they should seek medical attention before calling Public Health or telehealth
- Reminder to ensure PPE forms are completed with accuracy and contact information. Any incomplete forms will delay the process:
 - Time of delivery is approx. 2-7 days from the time it is approved. You will be receiving a notification when the process is approved by national office
 - Once PPE is delivered, please follow up with delivery company on delivery time as we do not have control over it
 - PPE vigilance: ensure it is in a secure location or place that is frequently monitored as thefts have been reported

Contact

- Probable and confirmed cases of COVID-19 are diseases of public health significance and have to be reported, please call your CD nurse
- Complete Severe Acute Respiratory Infection Form (Appendix 1 and 5) available on Onehealth, fax completed to 807-343-5348 (Confidential)
- For after hours reporting, contact the EPHO after hours phone line at 1-855-407-2676
- As with other reportable cases that would be of concern to the community, confirmed COVID-19 cases are also to be notified to your NIC/Health Director or designate, to communicate with Chief and Council. Confidentiality of the patient must be maintained
- If there is no Health Director or designate, NIC/CHN can also communicate with Chief and Council
- Chief and Council are welcome to contact our public health physicians if they have any questions or concerns following notification of a confirmed case.

Measures to Prevent and Control the Spread of the Virus

- Importance of physical (previously called social) distancing
 - Stay home as much as possible
 - Go out only for essential reasons like grocery shopping or to seek medical care;
 minimise these essential trips as much as possible
 - o If you are out, keep a distance of 2 metres between people
- Wash your hands frequently, do not touch your face with unwashed hands, and practice cough and sneeze etiquette
- If you feel sick you can self-isolate at home before and without being tested

- Take the Ministry of Health (MOH) <u>self-assessment tool</u> if you are worried you might have COVID-19, or if you have respiratory symptoms
- Seek health care for worsening or severe symptoms

Specimen Collection and Handling

- PPE for healthcare workers who are assessing someone with possible COVID-19 symptoms is droplet and contact precautions, unless they are performing an aerosol generating procedure such as intubation, in which airborne precautions would be advised in addition to routine precautions
