## COVID-19 in Ontario

- COVID-19 continues to circulate in Ontario with increased cases being reported
- Ottawa, Peel, and Toronto have reverted to a modified Stage 2 as of October 10, 2020
  - The rest of the province remains in <a>Stage 3</a> of reopening
- Ottawa, Peel, and Toronto have targeted measures for 28 days as a result of their higher than average rates of transmission which include:
  - o Indoor dining closed
  - o Indoor gyms closed
  - o Cinemas, theatres, casinos, indoor attractions
  - o No personal care services will be allowed where face coverings must be removed
  - o Food courts must be closed except for take-out
- Directive #5 for Public Hospitals within the meaning of the Public Hospitals Act and Long-Term Care Homes within the meaning of the Long-Term Care Homes Act, 2007- October 8, 2020

# Public health measures like watching your distance, washing your hands, and wearing a face covering remain very important

- Avoid crowded places, close contact, and closed spaces
- Avoid gathering, and keep 2 m distance from those not in your social circle
- Wear a <u>face covering</u> (cloth mask, non-medical mask) when running essential errands where you'll be indoors
- Stay home and self-isolate if you are sick, feel unwell, or <u>have symptoms</u> of COVID-19

- Retirement Home COVID-19 Visiting Policy (October 5, 2020) Effective October 13, 2020
- COVID-19: visiting long-term care homes (October 5, 2020) Effective October 7, 2020
  - o Starting Wednesday, October 7, 2020, general visitors will not be allowed in long-term care homes in the following communities. Only essential visitors, including up to one caregiver per resident, will be allowed to visit. If the home is experiencing an outbreak of COVID-19 the local public health unit will provide direction on further visitor restrictions and other measures.

## COVID-19 FNIHB-OR Epi Report

- As of October 13th, 2020, we have 90 First Nations confirmed cases and 7 non-First Nations confirmed cases. We currently have 9 active cases.
- Since the beginning of the pandemic, there have been 2 deaths.
- In total, 6,964 tests have been reported to FNIHB-OR.
- A grand total of 16,810 tests (including tests done in SLFNHA and WAHA areas).
- The province reported 649 cases of coronavirus on Sunday October 11<sup>th</sup>, 2020. Peel Region led the way in terms of having the largest number of daily cases per public health unit: 157 in Peel, 140 in Toronto, 87 in York Region and 54 in Ottawa. The total number of people who have died of COVID-19 in Ontario now stands at 3,005. More women than men have died of the novel coronavirus. Most deaths (69%) occurred in the 80 and over age range.
