COVID-19 in Ontario

- COVID-19 continues to circulate in Ontario
- All of the province is in <a>Stage 3 of reopening
- A free <u>app</u> is available to inform users if they may have been exposed to the COVID-19 virus you can learn more here

Public health measures like watching your distance, washing your hands, and wearing a face covering remain very important

- Avoid crowded places, close contact, and closed spaces
- Opening your '<u>social circle</u>' to up to 10 people may be considered these are people you can have close contact with keep 2 m from those not in your social circle
- Wear a <u>face covering</u> (cloth mask, non-medical mask) when running essential errands where you'll be indoors some areas of Ontario require you to wear a face covering find more information about how masks help here and here
- Stay home and self-isolate if you are sick, feel unwell, or have symptoms of COVID-19

Guidance Documents

The Ministry website was last updated 04 September 2020

- COVID-19 Guidance: Primary Care Providers in a Community Setting V6 (04 Sep 2020)
 - Clarification that for patients who screen negative and are coming to the office/clinic for vaccine administration, gloves are not required to be worn, but considered as per the Canadian Immunization Guide (Bullet 24)
 - o Removal of wording on "essential visits"
 - o Recommendation to actively screen all patients (and those accompanying them) upon entry to office/clinic, in addition to phone screening
 - o Masking for patients and accompanying persons for entirety of clinic visit
 - o In addition to symptomatic patients, testing should also be offered to, or arranged for, asymptomatic patients with a known or suspected exposure
 - o Requirement to self-isolate while working for asymptomatic primary care providers revised to reflect return from travel outside of Canada or to an area inside Canada with an elevated rate of COVID-19 (Bullet 31)
- Resuming Visits in Long-Term Care Homes (02 Sep 2020; effective 09 Sep 2020)
 - o Intended to supplement Directive #3 and considers safety, emotional well-being, equitable access, flexibility, and equality
 - o Describes roles and responsibilities, types (categories) of visitors, and their access to homes and outbreak areas as well as requirements for screening, PPE, management of safe visits, and non-adherence by visitors

Public Health Ontario (PHO) has basic online modules for <u>COVID-19 IPAC Fundamentals</u>, which support clinic staff, non-clinical staff, families, caregivers, and inspectors (updated 02 Sep 2020)

Public Health Ontario Lab (<u>PHOL</u>) has updated information, including <u>FAQs</u>, on <u>PCR collection kits</u> and lab testing for COVID-19

COVID-19 FNIHB-OR Epi Report

- As of September 4th, 2020, we have 64 confirmed cases. Of those cases, 62 or 97% have resolved. We currently have no active cases.
- Since the beginning of the pandemic, there have been 2 deaths.
- In total, 5,147 tests have been reported to FNIHB-OR. 1,033 tests (20%) are pending and 4,050 tests (79%) are negative.
- A grand total of 11,153 tests (including 4,094 tests from SLFNHA and 1,912 tests from WAHA).
- There are 29 health units reporting 5 or fewer cases. The majority of cases come from 4 health units: Toronto = 48 cases, Peel = 42 cases, Ottawa = 27 cases, York = 19 cases. Case count average for Ontario was 159 cases over last 7 days and represents a 35% increase in average since last week. 52% new cases reported today was in those less than 40 years of age. Average of 0 deaths per day over past 7 days, which is lower than last week.
