COVID-19 Situation in Ontario

- Continue to see an increase in cases in Ontario, however, no cases in First Nations communities in Ontario at this time

- As of 11:59 pm tonight, March 24, 2020, Ontario ordered the mandatory closure of nonessential workplaces/businesses
- Continue to recommend social distancing and self-isolation if unwell without waiting for testing
- If tested, when interpreting results, the test can be negative for COVID-19 but positive for other respiratory viruses including seasonal coronavirus

FNIHB Activities

- Messaging sent out on the PPE process with reminder to ensure forms are completed with accuracy and contact information. Any incomplete forms will delay the process:
 - Time of delivery is approx. 2-7 days from the time it is approved. You will be receiving a notification when the process is approved by national office
 - Once PPE is delivered, please follow up with delivery company on delivery time as we do not have control over it
 - PPE vigilance: ensure it is in a secure location or place that is frequently monitored as thefts have been reported
- FNIHB is currently in the process of creating tools to assist nurses in screening patients for covid-19 and self-isolation/quarantine information
- We have also shared a self-screening tool for nurses and health care workers, which the community can use for all other workers to self-screen prior to going into the community

Updates on Measures to Prevent and Control the Spread of the Virus

- If you feel sick you can self-isolate at home without being tested unless you need to seek health care for worsening or severe symptoms
